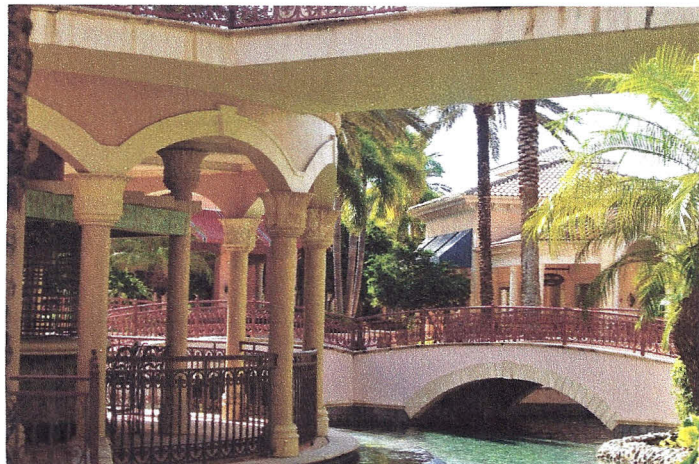

**The Annual Poinsettia Sale** is a major fund raiser for the Rotary Club of Bonita Springs which meets weekly in Bonita Bay.

All of the profit from the sale is used to help various charitable organizations in and around the immediate area. Twice a year we sponsor a "Gift of Life" child. This year we saved the lives of two young boys, both of whom were suffering from congenital heart defects and were in danger of dying if they did not get the lifesaving operations. Through our efforts we were able to bring them to the US from Belize and Ecuador so that they could have the needed surgery in order to live.

Club members also purchased wheel chairs to be shipped to third world countries. In the past year we sent over 250 chairs to Central America, and Haiti following the devastating earth quake there.

In all, last year over \$61,000 was sent to various local charities from the monies raised by selling Poinsettia plants, Christmas Trees and other fund raisers held throughout the year.



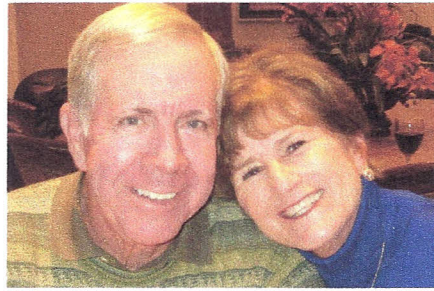
### **Ross Reynold Olander, Hidden Harbor**

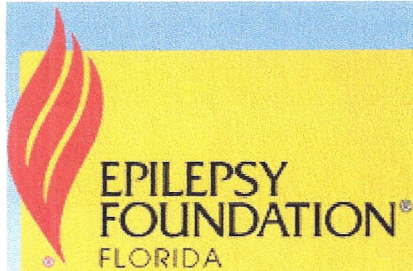


## October is Breast Cancer Awareness Month...

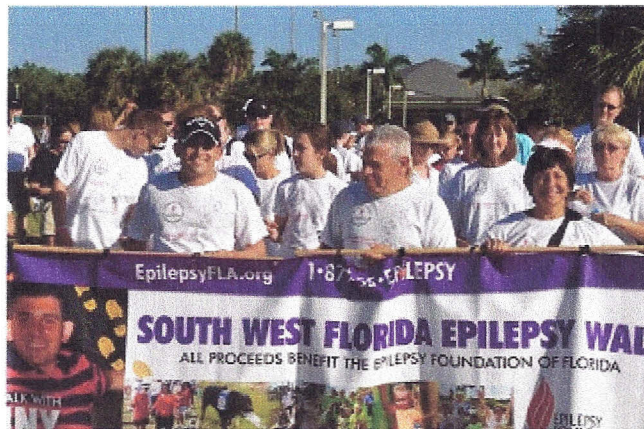
